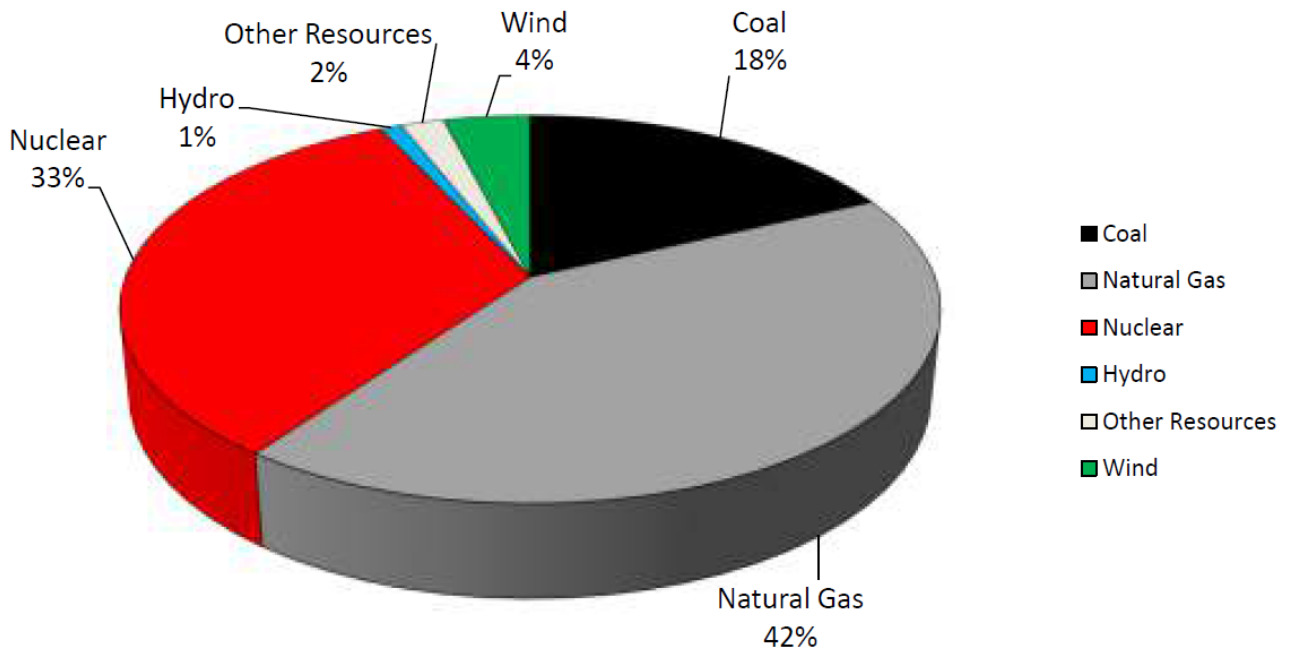
The benchmark emission levels that are shown approximate the emission rate for all electricity generation in the PJM region. Data used to calculate the emission profile came from generator owner-entered values, EPA generator-specific emission factors based on 2004/2005 CEMS data, EPA plant emission factors from eGRID or fuel-type default. CO is a "greenhouse gas" which may contribute to global climate change. SO and NO_x released into the atmosphere react to form acid rain. Nitrogen Oxides also react to form ground level ozone, an unhealthful component of "smog."

One hundred percent of the total electricity supplied was purchased from other suppliers and the amount of nuclear waste attributable to producing this electricity is not known and is not included in this table.
