<b>END OF CONTRACT</b>	Prior to the expiration date of the Initial Term, you will receive two separate written notifications explaining the proposed changes to the terms of service and your options going forward. The first notification will be provided no more sixty (60) days and no less than forty-five (45) days in advance of the expiration of the Initial Term. The second notification will be provided at least thirty (30) days in advance. If you find the change(s) unacceptable, you may choose another supplier or return to EDC service without any penalty to you. If you do not respond to the notifications, your service with Direct Energy will continue under the new terms and the Agreement, as amended, will automatically renew on a month-to-month basis at a variable rate or to another fixed term contract as set forth in the notifications with no early cancellation fee or device cost recovery fee.		
<b>RIGHT OF RESCISSION</b>	You have three (3) business days after you receive a written copy of this Agreement to cancel your enrollment with Direct Energy by calling Direct Energy using the contact information set forth in the Electric Generation Supplier Information section above. After the end of the Rescission Period, you can cancel service by using the contact information set forth in the Electric Generation Supplier Information section above.
